A regular meeting of the Main San Gabriel Basin Watermaster was duly and regularly held in the Conference Room of the City of Azusa Light and Water Administration Facility, at 729 North Azusa Avenue, in the City of Azusa, County of Los Angeles, State of California, 91702, on Wednesday, July 2, 2014, at the hour of 2:30 p.m.

CALL TO ORDER

James Byerrum, Chair, called the meeting to order and presided thereover.

PLEDGE OF ALLEGIANCE

ADOPTION OF AGENDA

The Chair asked if there were any changes to be made to the agenda. On motion made by Mr. Anderson, seconded by Mr. Michalko and unanimously carried, the agenda was adopted as presented.

ADOPTION OF A RESOLUTION APPROVING THE ADOPTION OF THE 2014 UPDATED GREATER LOS ANGELES COUNTY (GLAC) REGION INTEGRATED REGIONAL WATER MANAGEMENT PLAN (IRWMP) (Resolution No. 07-14-268)

Resolution No. 07-14-268 – The Executive Officer provided a brief review of the activities of the GLAC IRWMP, and stated that, as part of any agency's participation in the GLAC IRWMP, the agency must adopt a resolution in support of the plan update and file it with the California Department of Water Resources. He noted that Watermaster currently holds two seats on the IRWMP/Leadership Committee: Groundwater Representative, and Chair of the Upper San Gabriel and Rio Hondo River Sub-Region. Staff recommends that Watermaster approve Resolution No. 07-14-268.

RESOLUTION OF THE MAIN SAN GABRIEL BASIN WATERMASTER, APPROVING THE ADOPTION OF THE 2014 UPDATED GREATER LOS ANGELES COUNTY REGION INTEGRATED REGIONAL WATER MANAGEMENT PLAN

WHEREAS, the Main San Gabriel Basin Watermaster and agencies in the Greater Los Angeles County (GLAC) area have long recognized the importance of regional collaboration and integration of single purpose efforts and now regularly work across jurisdictional boundaries to implement regional projects and programs that address multiple water resource management issues including local and imported water supplies, sanitation and recycled water, stormwater management, groundwater management, water use efficiency, habitat and open space management, and many others; and

WHEREAS, the State of California Department of Water Resources (DWR) created the Integrated Regional Water Management (IRWM) Program to encourage integrated, regional strategies for managing water resources and to provide funding for both planning and implementation of projects that support management of water supply, water quality, environmental interests, drought protection, flood protection, and reduction of dependence on imported water and many other; and

WHEREAS, organizations participating in the IRWM Program join together to form IRWM Regions; and

WHEREAS, the IRWM Region serving the GLAC area is known as the GLAC IRWM; and

WHEREAS, the GLAC IRWM engages in regional water resources planning for the GLAC area; and

WHEREAS, DWR recognizes the GLAC IRWM as an official IRWM Region; and

WHEREAS, the IRWM Program requires that a Regional Water Management Group (RWMG) be formed to establish an IRWM Region; and

WHEREAS, the Main San Gabriel Basin Watermaster is a member of the RWMG for the GLAC IRWM and staff serves as the Chair of the Upper San Gabriel and Rio Hondo Rivers Sub-Region, and Groundwater Representative to the RWMG; and

WHEREAS, DWR and State Legislators have established program guidelines for the IRWM Program though Proposition 84 and Proposition 1E (2012 Guidelines); and

WHEREAS, the RWMG for the GLAC IRWM is responsible for the preparation and adoption an IRWM Plan; and

WHEREAS, the RWMG for the GLAC IRWM has developed the 2014 Updated GLAC IRWM Plan to addresses the provisions of the 2012 Guidelines; and

WHEREAS, the Main San Gabriel Basin Watermaster actively participated in the development of the 2014 Updated GLAC IRWM Plan; and

WHEREAS, adopting the 2014 Updated GLAC IRWM Plan will enable participants in the GLAC IRWM, including water purveyors in the Main San Gabriel Basin, to apply for future grant funding under various grant programs including Proposition 84 and Proposition 1E; and

WHEREAS, on June 21, 2011, the Board accepted Proposition 84 Planning Grant funds from DWR, together with funding contributions from members of the RWMG for the GLAC IRWM, to fund the development of the 2014 Updated GLAC IRWM Plan; and

WHEREAS, the 2012 Guidelines require the governing bodies of member agencies of the RWMGs, the RWMG representatives of the governing bodies, as well as proponents of projects included in IRWM grant funding proposals to adopt an updated IRWM Plan; and

WHEREAS, to date, DWR has awarded the GLAC IRWM Forty Eight Million and 00/100 Dollars (\$48,000,000.00) in grant funding to implement 27 regionally significant water resources management projects and has recommended the award of an additional Twenty

Three Million Four Hundred Thousand and 00/100 Dollars (\$23,400,000.00) for 13 more projects. NOW, THEREFORE, BE IT RESOLVED,: Adopt the 2014 Updated GLAC IRWM Plan; 1. Authorize and direct the Executive Officer, in their role as a member agency of 2. the RWMG of the GLAC Region IRWM, to vote at the appropriate time to adopt the 2014 Updated GLAC IRWM Plan. REQUEST FROM AZUSA LIGHT AND WATER TO PURCHASE 4,500 AF WATER FROM SGVMWD FOR PRODUCER CYCLIC STORAGE

The Executive Officer stated that Azusa Light and Water has submitted a request to purchase an additional 4,500 acre-feet of water from San Gabriel Valley Municipal Water District (SGVMWD) for its producer cyclic storage account. He noted that approval of this request requires a super majority of Watermaster members present; therefore, this item was deferred to the August meeting.

APPROVAL OF EIGHTH AMENDMENT TO BPOU PROJECT AGREEMENT

As previously reported by the Attorney at the June meeting, the Attorney stated that staff has been working with the BPOU Parties to approve Amendment Eight to the BPOU Project Agreement (Agreement), extending the Tolling Period for an additional four years. The Agreement has been extended a total of seven times, including an amendment in 2010 extending the tolling period for Parties' claims with regard to the Statutes of Limitations for those claims four more years, to May 2014. The amendment included a provision for the Parties to further extend that period another four years. This eighth amendment complies with that provision by extending the tolling period to May 7, 2018. However, since this amendment will extend past the current terms of the BPOU Agreement (Agreement expires in 2017), the actual terms of this amendment will be in effect only until a new agreement is reached.

The Attorney noted that he has received signatures from the Parties. On motion made by Chair Byerrum, seconded by Mr. Anderson, and unanimously carried, Watermaster approved the Eighth Amendment to the BPOU Project Agreement.

REPORT FROM BASIN WATER MANAGEMENT COMMITTEE

Mr. Michalko referred to a written Committee report included in the board packet. He reported that the Basin Water Management Committee (BWMC) met on June 11, 2014, and discussed a number of items, none of which require Watermaster action at this time.

Mr. Michalko also reported that scheduling is underway for a meeting of the BWMC ad hoc committee for Drought and Emergency Preparedness, tasked with determining which agencies will be most impacted by the low water levels, and to develop plans to provide supply to those agencies.

ATTORNEY'S REPORT

The Attorney reported that discussions continue relative to legislation relating to the proposed Wild and Scenic River Designation and the proposed Wilderness Designation. He stated that he has put forth some concerns with the proposed legislation, and all indications are that these concerns can be addressed. Additionally, the Attorney stated that he recently participated in a call with Congresswoman Chu's office, and others, regarding specific areas that will be affected. He is awaiting receipt of the final language for review.

Additionally, the Attorney reported on the United States Forest Service's interest with groundwater. He noted that this issue is active and moving through the process. He encouraged interested parties to research this matter closely.

ENGINEER'S REPORT

The Consulting Engineer provided a report on current water supply conditions, and stated that, as of June 20, 2014, the Key Well elevation was 188.4 feet, reflecting .40 foot decrease in elevation from the prior week. He stated that this is a new Historic Low for the Basin. The previous Historic Low was 189.2 feet, set in December of 2009. The water level in the Key Well is currently 15 feet lower than this same time last year, and is expected to continue dropping through October/November.

Additionally, the Consulting Engineer reported briefly on hydrologic conditions, and stated that rainfall recorded to date at the Los Angeles Civic Center is 4.8 inches, which is about 41 percent of average, and rainfall recorded at Puddingstone Dam is 6 inches, which is about 26 percent of average.

The Consulting Engineer also reported that inflow into the San Gabriel Reservoir is nonexistent; effectively, dry. Total canyon storage is currently at about 16,000 acre-feet. Relative to supplemental water supplies, the Consulting Engineer reported that efforts are underway to coordinate delivery of Colorado River Water (CRW) through CenB-48.

The Consulting Engineer also reported that all four landfills were inspected and found to be operating normally with no violations. He noted that a total of approximately 100,000 acrefeet is currently in cyclic storage.

The Consulting Engineer stated that production records for the past few years indicate a reduction in production. Production totals to date for this year, and at the same time of year for the past two years, are 45,800 acre-feet; 47,000 acre-feet; and, 49,000 acre-feet respectively. The Consulting Engineer added that he expects total production for the current year to be close to last year's total production.

Lastly, the Consulting Engineer referred to a written report included in the board packet that includes additional water supply and rainfall information.

EXECUTIVE OFFICER'S REPORT

The Executive Officer reported that a written copy of his report on Outside Activities is included in the board packet. He highlighted a few items, including a presentation by staff on the Water Resource Development Assessment to the San Gabriel Valley Council of Governments, and a presentation he gave at University of Southern California – Price School of Public Policy's Groundwater Strategy Workshop.

Additionally, the Executive Officer reported that staff is continuing to work with USGVMWD to coordinate delivery of CRW to the Basin. Lastly, he stated that consideration of

implementing an in-lieu assessment to facilitate delivery of CRW may be discussed by an ad hoc committee in the near future.

REPORT FROM RESPONSIBLE AGENCIES

Mr. Brian Bowcock, representing Three Valleys Municipal Water District (TVMWD), reported that an algae bloom in Silverwood Lake is beginning to impact TVMWD's water supply. The algae bloom creates a musty taste and odor to the water but does not pose a health concern. Mr. Bowcock stated that the Department of Water Resources plans to treat the algae bloom within the next two weeks.

Additionally, Mr. Bowcock reported that TVMWD has concerns with the National Recreation Area's proposed area map. He noted that TVMWD's spreading grounds was supposed to be excluded from the area included within the designation; however, the new area map includes the spreading grounds. Mr. Bowcock advised others to review the proposed area map for possible impacts to their service areas.

Mr. Shane Chapman, reporting on behalf of USGVMWD, referred to a written report provided to Watermaster. He welcomed any questions anyone may have.
