IV. Discussion regarding Resolution supporting ACWA's Water Action Plan for California

The Executive Officer distributed copies of the sample resolution provided by ACWA in support of its Statewide Water Action Plan for California.

The Committee asked ACWA representative Greg Galindo to provide a brief overview. He stated that discussions he has had regarding this matter are all favorable in supporting the plan. It is aimed at protecting groundwater statewide; no negative impacts to Southern California, or the Main San Gabriel Basin are anticipated.

V. Other

Mr. Jim Byerrum reported that the Water Quality Authority took action at its Board meeting to support Ms. Kathleen Tiegs for Vice-President of ACWA. He suggested that the Committee authorize the Executive to cast his votes in favor of Ms. Tiegs. The consensus of the members present was to support Mr. Byerrum's suggestion. The Executive Officer noted that given the timing of the election and the authority he holds as Watermaster's representative, he will vote as suggested on December 4th at the ACWA election.
